1 EVENT SUMMARY

Article 1.1 - EVENT SUMMARY

THESE REGULATIONS ARE TO BE READ IN CONJUNCTION WITH THE 2009 CAMS MANUAL AND ANY FURTHER REGULATIONS, BULLETINS OR INSTRUCTIONS ISSUED BY THE ORGANISERS.

- 1.1.1 The event will be held under the International Sporting Code of the FIA, the National Competition Rules of CAMS, CAMS Rallysprint Standing Regulations, SA Conditions for Rallies and these Event Supplementary Regulations, Further Regulations and any Bulletins or Instructions to competitors that may be issued.
- 1.1.2 Where there is any divergence between THE 2009 CAMS MANUAL and these Event Supplementary Regulations, The Event Supplementary Regulations will take precedence.
- 1.1.3 The 2009 ASP SA Rallysprint Championship, hereinafter referred to as 'the event'
- Will use electronic timing to 0.01 second.
 - Is approved to run by CAMS.
 - Will be a stand alone State Rallysprint Championship and Round 4 of the SA Clubman Series, and is open to all CAMS affiliated car clubs.
- 1.1.4 The CAMS Permit Number authorising the event is 509/2510/02
- 1.1.5 The Event will comprise of approximately 96km of competitive and 10 km of transport.
- 1.1.6 Insurance for the event is covered under CAMS permit No 509/2510/02 please see Appendix 1 Section 15 Insurance / Fees Part 2 for further details.
- 1.1.7 Crews involved in accidents resulting in property damage are advised that they may be required to pay up to the first \$5000 of any claim to rectify such property damage. Refer Appendix I of the CAMS Manual of Motor Sport for further details regarding insurance cover.

5 JUDGES OF FACT

Article 5.1 - JUDGES OF FACT

5.1.1 JUDGES OF FACT

In accordance with NCR 181 the following officials are deemed to be Judges of Fact

- Officials of the event are deemed to be Judges of Fact of the following
 - Not wearing seat belt, helmet or safety clothing
 - Service Park infringements
 - Shortcutting the course
- Scrutineers are deemed to be Judges of Fact of the following:
 - Vehicle in un-roadworthy condition
 - Vehicle with accident damage
 - Weight of a vehicle
 - Eligibility of Vehicles
 - Driver Apparel
- Medical Officers are deemed to be Judges of Fact of the Medical condition of
 - Any crew member or team member.
- Speed Monitoring Officials using suitable equipment are deemed to be Judges Fact to the Speed
 - Of a competing vehicle or service vehicle.

6 COMPETITOR ELIGIBILITY

Article 6.1 - COMPETITOR ELIGIBILITY

- 6.1.1 The driver shall hold, as a minimum, a current CAMS Clubman rally Licence. Drivers who are under 16 or do not hold a civil drivers licence will need a co-driver with a civil drivers licence to drive between the 2 forest stages. Competitors doing the SA Clubman Series will need a Driver and Co-Driver. Competitors competing in the SA Rallysprint Championship can run by themselves or with a Co-Driver. A vehicle can be double entered with two separate drivers or co-drivers.
- 6.1.2 The Organisers reserve the right to review and exclude any driver who has been identified in the past or during the event in any officially observed incidents that bring the sport into disrepute, either prior or during the event.

7 VEHICLE ELIGIBILITY

Article 7.1 - VEHICLE ELIGIBILITY

8 DRUGS IN MOTORSPORT

Article 8.1 - DRUGS IN MOTORSPORT

8.1.1 All Competitors and Service Crew Members are reminded of the CAMS Anti-Doping policy in the Current CAMS Online Manual of Motor Sport (section 2, General Regulations).

8.1.2 Tests for Alcohol may be conducted at any time during the event in accordance with the “Procedure for Alcohol Testing” in the Current CAMS Online Manual of Motor Sport.

9 RUNNING OF THE EVENT

Article 9.1 - RUNNING OF THE EVENT

9.1.1 The driver **MUST** be present at Competitors' briefing at 0900 hrs on **25th Oct 2009** at the Event Headquarters. Non attendance will be a penalty of refusal to start.

9.1.2 The Event will start at **1000** hrs on **Sunday 25th Oct 2009** and the last car will finish at approx 1700 hrs.

9.1.3 Crews will complete the two, 8km stages then return to the service park before commencing their second run through the 2 stages, then return to the service park again before completing their 3rd run through the 2 stages. Once all cars have completed the first 2 stages, the course will be reversed for competitors to have 3 runs through each stage as per the previous 2 stages.

9.1.4 Depending on the number of entries, cars may start at either a 90 second or 60 second intervals.

10 SEEDING

Article 10.1 - SEEDING

10.1.1 Cars entering the SA Championship will be seeded in class order. Cars entering the Clubman Series will be seeded in DPI order where possible.

11 ENTRY DETAILS

- 11.1.3 The organisers reserve the right to cancel or postpone the event should the number of entries be less than 25 or due to circumstances which result in force majeure. Maximum limit of entries is 60.

12 SERVICE AND RE-FUELLING

Article 12.1 - SERVICE AND RE-FUELING

- 12.1.1 The maximum distance between re-fuelling will be approximately 16km of competition.
- 12.1.2 Re-fuelling can ONLY be carried out within the re-fuel zone at the service park by service crews.
- 12.1.3 AVGAS – The use of Avgas is not permitted in South Australia. Any vehicle suspected of using AVGAS will be required to submit to a fuel sample for testing, at the organiser's discretion. Any vehicle suspected to be in breach of the current CAMS fuel requirements will be reported to the Event Stewards. The recommended penalty will be exclusion.
- 12.1.4 The speed of cars in the service park must not exceed 10km/h; offenders will be reported to the Stewards of the Event, who will decide on a penalty.

13 DOCUMENTATION AND SCRUTINY

Article 13.1 - DOCUMENTATION AND SCRUTINY

- 13.1.1 Documentation will be available at Cut Price Truck Rentals, 41 Sir Donald Bradman Drive Mile End South Adelaide, during the following times and must be completed prior to presentation of that vehicle for scrutiny – 1830 hrs to 2100 hrs on Thursday 22nd Oct 2009.
- 13.1.2 Vehicles must be presented for scrutiny between 1830 hrs and 2100 hrs on Thursday 22nd October 2009.
- 13.1.3 Vehicles requiring re-scrutiny are required to attend scrutiny at 0800 hrs Sunday 25th Oct 2009.
- 13.1.4 Documents to be presented at documentation include:
- CAMS Competition Licence
 - CAMS Automobile Log Book (if the vehicle has one)
 - CAMS Affiliated Club Membership Cards
 - Civil Drivers Licence for those over 16 years
 - Vehicle Registration Papers/Permit
- All documents presented must be current & not expire over the duration of the event.
- 13.1.5 Either the Driver or Co-Driver (if applicable) MUST be present at documentation.
- 13.1.6 Any competitor who fails to meet vehicle re-presentation requirements as directed will be refused permission to start the event.
- 13.1.7 Post event scrutiny will take place within 1 hour of the selected vehicle finishing the event. Those crews concerned will be advised when returning to the service park.
- 13.1.8 Of the remaining competitors those who wish may leave the event after their final run by signing a declaration that if subsequently required for scrutiny, they will be deemed to have withdrawn from the event and will not be eligible for any awards.
- 13.1.9 Parc fermé will be located close to the service park where all vehicles will be held until post event scrutiny has been completed or the Stewards allow them to be removed..

14 PROTESTS

Article 14.1 - PROTESTS

- 14.1.1 Protests, if any, must be lodged in accordance with Part XII of the NCR. Protests relating to the due and proper compilation, assessment or publication of results of the competition shall be lodged within 30 minutes of their being placed on the official notice board.

15 RESULTS

Article 15.1 - RESULTS

- 15.1.1 The fastest 2 runs per stage will be counted towards the results. If there is only two runs on a stage instead of 3 then both runs will count.
- 15.1.2 Final Results will be posted on the asprally web-site www.asprally.com on Wednesday 28th Oct 2009.

16 AWARDS

Article 16.1 - AWARDS

Awards will be given to 1st, 2nd and 3rd in the SA Rallysprint Championship as well as the SA Clubman Series. For the purpose of CAMS awards, classes with less than 3 cars will be amalgamated with the closest compatible class at the Clerk of Course discretion.

Event trophies will awarded to 1st in each class regardless of the number of cars in each class.
